

Software License

The service and the use of the software are provided by Foto Master Ltd. (hereinafter: the “Company”). It is hereby clarified and agreed that the use and operation of the software indicate the acceptance of the following terms and full agreement thereto without any restriction and/or reservation.

It is hereby clarified, that the software is to be used only after carefully reading all of the terms and conditions set forth in this agreement.

Downloading, installing and/or use of the software constitute acceptance of all the terms of the license. If you did not agree to the terms of use listed in this License Agreement, avoid installing the software and/or making any use thereof.

The software means the software offered for download on this site, files, documents and/or fonts attached to the software.

Terms of use and restrictions
